- 3 Status of Investor Complaints for the quarter ended 30 June 2011: Complaints pending at the beginning of the quarter- Nil; Complaints received during the quarter - 5; Complaints at the end of the quarter - Nil.
- 4 Out of the fund raised from Initial Public offer (IPO) amounting to Rs 315.54 crores, apart from meeting the IPO expenses of Rs. 23.32 crores, the Company has utilised the proceeds of the issue amounting to Rs. 218.37 crores for setting up and expansion of manufacturing units, setting up of retail outlets, meeting working capital requirements and for general corporate purposes upto the quarter ended 30 June 2011. The unutilised fund of the issue amounting to Rs. 73.85 crores has been temporarily invested in interest bearing liquid instruments including deposit with banks and investment in mutual funds.
